## MUNICIPALITY OF BRENDA-WASKADA <u>PROVINCE OF MANITOBA</u> <u>By-Law No. #39-2023</u>

## A BY-LAW OF THE MUNICIPALITY AUTHORIZING THE MUNICIPALITY OF BRENDA-WASKADA TO INCREASE ITS PER CAPITA LEVY FOR THE BREN-DEL- WIN CENTENNIAL LIBRARY.

**WHEREAS** the Town of Deloraine, the Rural Municipality of Winchester and the Rural Municipality of Brenda entered into an Agreement on the 25<sup>th</sup> day of January, A.D. 1979 for the establishment, maintenance and operation of a Regional Library;

**AND WHEREAS** Paragraph 7 of the agreement provided that on January 15<sup>th</sup> in each and every year of the agreement a budget was to be presented to each Council of the Municipalities herein whereby the annual operating expenses would be equally divided among the municipalities, but the total requirement shall not exceed \$4.00 per capita;

**AND WHEREAS** the above agreement was mended in 1992 to increase the per capita to \$8.00, which was approved by Municipal Board Order No. D-92-005;

**AND WHEREAS** the above agreement was further amended in 1993 to increase the per capita to \$10.00 which was approved by Municipal Board Order No D-93-004;

**AND WHEREAS** the costs associated with the operation of the Regional Library have escalated to the point where \$10.00 per capita is no longer sufficient to raise the funds required by The Regional Library.

**AND WHEREAS** said Municipalities have agreed that the Agreement dated the 25<sup>th</sup> day of January A.D. 1979, as amended in 1992 and approved by Municipal Board Order No.D-92-005 and amended in 1993 by Municipal Board Order No. D-93-004, shall be further amended to provide that a levy payable by each municipality shall not exceed \$15.00 per capita.

**AND WHEREAS** it is deemed to be in the best interest of the Municipality of Brenda-Waskada to further amend said agreement.

**NOW THEREFORE**, in Council duly assembled, the Council of the Municipality of Brenda-Waskada does hereby enact as follows:

1. **THAT** the Municipality of Brenda-Waskada to further amend the maximum per capita contribution to the Municipalities of Deloraine-Winchester and Brenda-Waskada the amounts set forth in the following years:

2023	27.50
2024	30.00
2025	32.50
2026	35.00
2027	37.50

- 2. **THAT** the increases set out in Section 1 of this by-law shall come into effect January 15<sup>th</sup>, of the designated years.
- 3. THAT the increase shall not be effective until both Municipalities have passed By-laws for said increase.
- 4. **THAT** the Head of Council and/or Chief Administrative Officer be and are hereby empowered to execute any and all documents necessary to amend said agreement.
