Zoom Delegation to meeting: Travis Lyle, Dale Lyle of Way to Go Consulting. Results of the PUB rate study were reviewed.

Whereas the Municipality of Brenda-Waskada has received a Utility rate study for the Rural Water and Wastewater Utility;

And Whereas the Rural Utility incurred audited PSAB, PUB adjusted deficits of Deficits of \$325,149 in 2017, and \$12,346 in 2018;

And Whereas the Rural Utility has a Working Capital Surplus in 2022 of \$386,283, which exceeds 2022 minimum working capital surplus requirements of \$24,569;

Therefore Be It Resolved that the Municipality of Brenda-Waskada request approval from the Public Utilities Board for the 2017 and 2018 Rural Utility deficits of \$325,149 and \$12,346, respectively, with said deficits to be recovered through draw-down of the accumulated fund surplus;

And Further Be It Resolved That By-Law 41-2024 to establish Rural Utility rates be given first reading and submitted to the Public Utilities Board for approval.

### Carried

Whereas the Municipality of Brenda-Waskada has received a Utility rate study for the Waskada Water and Wastewater Utility;

And Whereas the Waskada Utility incurred audited PSAB, PUB adjusted deficits of \$13,864 in 2019 and \$8,032 in 2022;

And Whereas \$8,032 exceeds 5% of annual Waskada Utility operating expenses;

And Whereas the Waskada Utility has an audited working capital surplus in 2022 of \$175,110, which exceeds 2022 minimum working capital surplus requirements of \$16,618;

Therefore Be It Resolved that the Municipality of Brenda-Waskada request approval from the Public Utilities Board for the 2019 and 2022 Waskada Utility deficits of \$13,864 and \$8,032, respectively, with said deficits to be recovered through draw-down of the accumulated fund surplus;

And Further Be It Resolved that By-law No. 42-2024 to establish Waskada Utility rates be given first reading and submitted to the Public Utilities Board for approval.
