

## **Municipality of Brenda-Waskada**

### **By-Law #40-2024**

**BEING A BY-LAW TO ESTABLISH A RATE FOR road construction and maintenance, snow removal and dust control, tree planting and care, grass and weed cutting and control, collection and transportation of waste and recyclable materials, recreation support, street lighting, fire and police protection, emergency management services, drainage, and the maintenance or operation of a local improvement, as a special service in the community of Waskada for the years 2024 and 2025.**

**WHEREAS** Section 312 of *The Municipal Act* of Manitoba, provides in part as follows:

**312** If approved by by-law, a municipality may provide, as a special service to all or part of a municipality, one of more of the following:

- (a) road construction and maintenance;
- (b) snow removal and dust control;
- (c) tree planting or control of a plant or tree disease;
- (d) grass and weed cutting and control;
- (e) the collection and transportation of waste or recyclable materials;
- (g) recreation support services;
- (h) street lighting;
- (i) fire and police protection services;
- (i.1) emergency management services;
- (k) drainage construction and maintenance;
- (l) maintenance or operation of a local improvement.

**AND WHEREAS** subsection 320(1) of the Act provides as follows:

**320(1)** Subject to subsections (2) to (6) and subsection 321(4), a council may by by-law

- (a) approve the local improvement or special services as set out in the plan or proposal; and
- (b) authorize the municipality to impose taxes as set out in the plan or proposal.

**AND WHEREAS** the Council of the Municipality of Brenda-Waskada has prepared Special Services Plan No. 1-2024 to establish a rate for the road construction and maintenance, snow removal and dust control, tree planting and care, grass and weed cutting and control, collection and transportation of waste and recyclable materials, recreation support, street lighting, fire and police protection, emergency management services, drainage, and the maintenance or operation of a local improvement as a special service pursuant to Part 10 of the Act;

**AND WHEREAS** the requirements as prescribed in section 318, 319, and 320 of the Act have been complied with;

**NOW THEREFORE** the Council of the Municipality of Brenda-Waskada, in open council assembled enacts as follows:

- 1.** That pursuant to subsection 320(1) of the Act, Municipality of Brenda-Waskada approves Special Service Plan No. 1-2024 attached hereto as Schedule “A”.

2. That the Municipality of Brenda-Waskada levy an annual special service tax upon all rateable properties within the municipality as hereby attached in Schedule “B”.
